The candidate(s) shall report in their respective offices as mentioned above within a period of 21 days from the date of issuance of this order. In case, a candidate fails to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointee(s) shall be allowed to join only after production of the following certificates/documents (in original) to be verified separately by the concerned office/division:-

- i. Educational/Technical qualification issued by the recognized Institute/University.
- ii. Matriculation/Date of Birth certificate.
- iii. Domicile certificate issued by Competent Authority
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. If the candidate(s) has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stacks, if any, in such self-employment unit/ enterprise before the joining the Government Services. He/ She shall be required to liquidate the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stacks, if any in such a self-employment unit/enterprise and recovery to be made and personally monitor its recovery.
- vi. Relevant category certificate issued by the Competent Authority, if any applicable.



The appointment of the above candidate, as "Junior Assistant" (as prescribed in the above said Govt. Order) shall further be subject to the following conditions:

- a) The appointee shall furnish an undertaking in the shape of an affidavit to the effect that he/she has no criminal record and is not facing any criminal proceedings in any Hon'ble Court of Law.
- b) The salary of the appointees shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/diploma certificate/Date of birth/ relevant category and other pre-requisite certificate(s) is received from the concerned issuing authority. In case during the course of verification of the requisite documents, turns out to be fake/fictitious, the appointment shall be cancelled ab-initio and appropriate criminal proceedings against such candidate shall be initiated accordingly.
- c) The inter-se seniority of the appointee shall be determined in accordance with the merit secured by him in the selection list prepared by the J&K Service Selection Board.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated: 24.12.2009.
- e) The candidate(s) appointed under RBA and ALC/IB category shall be posted in such areas at least for 07 years.
- f) The appointee shall be on probation for a period of two (02) years as per Rule 20 of J&K Civil Service (CCA) Rule, 1956.
- g) The appointments of the above candidates shall be subject to outcome of writ petition(s), if any, pending before a competent Court of Law.
