The candidate(s) shall report in the above offices within a period of 21 days from the date of issuance of this order. In case, the candidate fails to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.

The The appointee(s) shall be allowed to join only after production of the following certificates/documents (in original) to be verified separately by the concerned office/division:-


- i. Educational/Technical qualification issued by the recognized Institute/University.
- ii. Matriculation/Date of Birth certificate.
- iii. Domicile certificate issued by Competent Authority
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. Relevant category certificate issued by the Competent Authority, if any applicable.

The appointment of the above candidate, as "Junior Assistant" (as prescribed in the above said Govt. Order) shall further subject to the following conditions:

- i. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his/her Qualification/Date of Birth/ Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment as Junior Assistant in the Jal Shakti Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- ii. That If the candidate(s) has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/ enterprise before the joining the Government Services. He/ She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stacks, if any in such a self-employment unit/enterprise and recovery to be made and personally monitor its recovery.

- iii. The salary of the appointees shall not be drawn and disbursed to him/her unless satisfactory report in respect of genuineness of his/her qualification/diploma certificate/Date of birth/ relevant category and other pre-requisite certificate(s) is received from the concerned issuing authority.
- iv. The inter-se seniority of the appointee shall be determined in accordance with the merit secured by him/her in the selection list prepared by the J&K Service Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- v. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated: 24.12.2009.
- vi. The appointee shall be on probation for a period of two (02) years.
- vii. The appointments of the above candidates shall be subject to outcome of writ petition(s), if any, pending before a competent Court of Law.
