DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stacks, if any in such a self-employment unit/enterprise and personally monitory its recovery.

vi. Relevant category certificate issued by the Competent Authority, if any applicable.

The appointment of the above candidate, as "Junior Assistant" (as prescribed in the above said Govt. Order) shall further subject to the following conditions;
