In pursuance to the powers conferred under SRO-43 of 02/1994, sanction is hereby accorded to the temporary appointment of Smt. Jyoti Sharma w/o Jagdish Raj, Ex. Amin R/o H.No 139 Lane no. 5 Lakkar Mandi, Janipur Tehsil Jammu North District Jammu as Class-IV/MTS (Orderly) in the pay level of SL-1 (14800-47100) and posted in Irrigation Division-1st Jammu against the available vacancy.

The appointee shall report to the Executive Engineer Irrigation Division-1st Jammu within a period of twenty one days from the date of issuance of this order and shall be allowed to join only production and verification of the following documents/certificates in original:

- i. Academic Qualification Certificate.
- ii. Domicile Certificate.
- iii. Health Certificate from the concerned District Chief Medical Officer.
- iv. Dependent Certificate issued by the concerned authority.
- v. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vi. Un-employment certificate from District Employment Exchange
- vii. Fresh Un-Married Certificate
- viii. All other relevant documents as required under SRO-43/1994

The appointment of the appointee shall further be subject to the following conditions:

- a) That she will give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate, 1st Class to the effect that if on verification from the concerned issuing authority, certificates/documents produced by the appointee are proved to be fake /forged, the appointment shall be cancelled ab-intio and the legal action as warranted under rules shall be initiated against the appointee.
- b) The appointees shall be initially on probation for a period of two years.
- c) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (a) above is received in her favour.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated: 24.12.2009.
- e) The candidate shall join within a period of 21 days from the date of issuance of this order. In case, the candidate fails to join within the stipulated period, her appointment shall be deemed to have been cancelled ab-initio without any further notice.
- f) The appointee shall give an undertaking to the effect that she will look after her other family member(s) and dependent(s) of the deceased employee after her appointment.
