- 3. The amount is being released subject to the following:
- (i) The work is to be executed as per the MoU and ToR.
- (ii) The release of financial assistance to the States/States agencies shall be within 10 days of transfer of funds to NIH by NWM, DoWR, RD&GR (iii) The release amount will be spent only for the purpose for which it has been sanctioned.
- (iv) NIH would conduct as inception course for Nodal Agencies and Officers of the States/UTs (v) NIH may also enter into agreements with the respective State/UTs.
- (vi) NIH shall also be responsible for ensuring that the physical and financial targets are adhered to by the States/UTs for preparation of SSAP.
- (vii) NIH will also be responsible for close coordination and ensuring that deliverables envisaged are provided to DoWR as per schedule and would assist the committees envisaged as may be (viii) The timeframe for completion for preparation of SSAP by the States/UTs is one year.
- (ix) All interests or other earnings against Grants in aid or advances (other than reimbursement) released should be mandatorily remitted to the Consolidated Fund of India immediately after finalization of the accounts. Such advances should not be adjusted against future releases

(x) Utmost austerity measures would strictly be adhered to and the expenditure will be limited to estimates approved or actual expenditure whichever is lower.

(xi) The assets being created would be property of Government of India and its disposal will be decided on completion of Project with the approval of competent authority.

(xii) Conformity to the approved scheme of R&D and Implementation of National Water Mission for the 15th FC.

(xiii) A Utilization Certificate, in the format 12C as per GFR 2017, will be submitted by "NIH" for the central assistance in the prescribed format at the time of making proposal for the next release for the project as stimulated in Financial Management Guidelines of MoA.

(xiv) Under any circumstances funds should not be diverted to any other scheme or any other accounts.

(xv) The provisions under GFR2017 and directions of MoF/CVC would be adhered to. (xvi) In terms of GFR 236(1) i.e. the accounts prepared in terms of Rule 235 shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India the provision of CAG (DPC) Act 1971 and internal audit by the principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. (xvii) The grantee institute agrees to make reservations for Scheduled Castes and Scheduled Tribes or OBC in the posts or services under its control on the lines indicated by Government of
